**Spencer's Run
Membership Rules and Regulations**

Please initial each rule as an acknowledgement that you have read and understand each rule, and agree to abide by it. Please note that dogs must be free of communicable illnesses or external conditions, such as parasites, fleas, mange, or kennel cough.

- _____ All dogs must be spayed or neutered. This is a rule at many dog parks and is recommended as a tactic to reduce the possibility of dog fights.
- _____ Dogs must display current rabies tag, Town license, and Spencer's Run ID tags on their collars at all times when in the Dog Park.
- _____ Owner/Handler maximum of 3 dogs per visit.
- _____ Children five and under are prohibited from entering Spencer's Run – no exceptions. This is for the protection of the children.
- _____ Children under 15 years must be accompanied by an adult and should not run, chase dogs, or pet other people's dogs unless permission is granted by the owner. Children are not allowed to bring toys into the park, such as sports equipment.
- _____ No one may bring equipment such as wading pools or agility equipment into Spencer's run unless specifically permitted by the Director of Recreation.
- _____ When entering Spencer's Run, remove your dog(s) leash only in the corralled area. Prong collars, choke collars and chains, or spike collars must be removed from dogs prior to entering the run.
- _____ Do not allow others to enter without their own pin codes.
- _____ Dogs displaying aggressive behavior toward people or other dogs must be leashed and immediately removed from the park by owners/handlers.
- _____ Owners/handlers must remain inside of the fenced area, with leash in hand, and within view of their dogs at all times.
- _____ Owners/handlers must properly clean up after their dog(s) and take their dog's waste when leaving Spencer's Run. All waste must be disposed of only in the dumpster, which is located in the parking lot. It is important for all members to keep a clean safe park for our dogs to use.
- _____ Owners/handlers must stop their dogs from digging and immediately fill any holes in order to help avoid injuries.
- _____ No dog treats, rawhide chews, human food, alcohol or smoking are allowed within the fenced area. No glass containers are allowed.

I have read, understand, and agree to abide by all of the Dog Park Rules and Regulations. I understand that violations of these rules may result in the loss of the privilege to use Spencer's Run without a refund of dues. I understand that the Town of New Canaan reserves the right to alter or amend these rules and regulations at any time. I also accept full and total responsibility for insuring that any user I have authorized understands and obeys these rules, whether I am in attendance or not.

I hereby agree to hold harmless and indemnify the Town of New Canaan, its officers, employees, volunteers, and agents, from any and all liability, claims, demands, causes of action, loss, damage or injury to person or property, including death and serious or other damage or injury which may be caused by myself, my guest(s), my property, my dog(s) or any additional user(s) I have authorized while on the dog park premises.

I am 18 years old or older and have the legal capacity to enter into a binding agreement. I intend for this release to be binding upon my heirs, successors, beneficiaries, next of kin, personal representatives or executors, and assigns.
